# FAIR WEAR & TEAR GUIDELINES

### FAIR WEAR AND TEAR GUIDELINES: SUMMARY

- Isolated stone chips to any panel up to 2 mm in diameter without denting (excluding windscreens)
- Scratches less than 20mm in length and not more than 1mm wide that have not penetrated the paint and can be polished out.
- Dents less than 20 mm in diameter where the paint surface has not been broken and there is no paint removal, paint cracking or flaking (excluding dents to the bonnet or roof)
- Light Wheel scratches or scuffs up to 20 mm in length without cracking, buckling, or gouging.
- Scuffs/scrape marks under lower front bumper (not visible when standing 2m back from vehicle)

#### FAIR WEAR AND TEAR GUIDELINES: DETAILED

DENTS		
Fair Wear and Tear <b>includes</b> : Dents of no more than 20 mm in diameter (excluding bonnets and roofs) where the paint surface has not been broken and there is no paint removal, paint cracking or flaking.	<ul> <li>Fair Wear and Tear excludes:</li> <li>a) dents of any diameter on bonnets, roofs, wheel arches, style lines, door sills or door edges.</li> <li>b) multiple dents within a specific local area regardless of size; or</li> <li>c) any damage affecting or penetrating the paintwork.</li> </ul>	
STONE CHIPS		
Fair Wear and Tear <b>includes</b> : Isolated stone chips to any panel up to 2 mm in diameter.	Fair Wear and Tear <b>excludes</b> : More than 5 stone chips to an isolated area.	
SCRATCHES		
<ul> <li>Fair Wear and Tear <b>includes</b> Light scratches:</li> <li>a) not more than 20 mm in length and not more than 1 mm wide.</li> <li>b) no paint surface penetration; and can be polished out.</li> </ul>	Fair Wear and Tear <b>excludes</b> : Any scratch where the metal, plastic or undercoat is exposed.	

# FAIR WEAR & TEAR GUIDELINES

Fair Wear and Tear <b>includes:</b>	Fair Wear and Tear <b>excludes:</b>	
<ul> <li>a) Scratches/Scrapes under the front bumper that are not visible when standing 2 metres back from the vehicle: or</li> <li>b) light scuffing or scratches: <ul> <li>(i) where there is no paint penetration.</li> <li>(ii) which are no more than 20 mm in length; and which can be polished out.</li> <li>(iii) isolated stone chips up to 2 mm in diameter.</li> </ul> </li> </ul>	<ul> <li>any broken paint.</li> <li>multiple scratches of any size.</li> <li>dents of 20 mm or more in diameter.</li> <li>any damage to a textured bumper; and multiple stone chips of more than 5 to an isolated area.</li> </ul>	
WHEELS, V	VHEEL TRIMS, TYRES	
Fair Wear and Tear <b>includes:</b>	Fair Wear and Tear <b>excludes:</b>	
Light scratches and scuffing up to 20 mm in length.	<ul> <li>a) wheel trims or hubcaps that are cracked, broken, missing, mismatched or not the original wheel trim or hubcap.</li> <li>b) alloy rims if: <ul> <li>(i) a scuff mark is more than 20 mm in length.</li> <li>(ii) the alloy rim is cracked, buckled, or gouged; or</li> <li>(iii) the alloy rim is mismatched or not the rim as originally supplied.</li> </ul> </li> <li>c) tyre tread and sidewall damage so that the tyre is unroadworthy e.g. cuts, bulges, gouges and abrasions, tyre misuse e.g. flat spots and burnouts.</li> <li>d) replacement tyres that differ from those originally supplied.</li> </ul>	
WINDSCREEN, WINDOWS, LAMPS, AND EXTERNAL MIRRORS		
	<ul> <li>Fair Wear and Tear excludes:</li> <li>Scratches, chipping, cracks, holes, or damage to: <ul> <li>a) the windscreen.</li> <li>b) windows.</li> <li>c) lamps; and</li> </ul> </li> <li>d) external mirror lens, as all such damage may affect the roadworthy status of the vehicle and may subsequently worsen over time from the vehicle continuing to be driven.</li> </ul>	
UPHOLSTERY, FLOORS, CARPETS, DASHBOAI	RD, FASCIA, TRIM INTERIOR AND VEHICLE CLEANLINESS	

### FAIR WEAR & TEAR GUIDELINES

Fair Wear and Tear <b>includes:</b>	Fair Wear and <b>Tear excludes:</b>	
<ul> <li>a) light marks that can be removed by vacuum or general cleaning.</li> </ul>	<ul> <li>any permanent damage caused by harsh or corrosive materials.</li> </ul>	
b) light scuffing or smears or regular day to day debris that is removable by general cleaning	b) tears, cuts, scratches, holes or burns.	
	c) any damage to the structure, shape or positioning of a seat.	
	d) hair from pets.	
	e) excessive soil, mud, or sand (other than from regular day to day use).	
	f) evidence of smoking in the vehicle.	
	g) odours or foreign matter;	
	h) stains or marks that cannot be removed by general cleaning or require steam cleaning.	
KEYS, ACCESSORIES AND EQUIPMENT		
Fair Wear and Tear <b>includes:</b>	Fair Wear and Tear <b>excludes:</b>	
Minor cosmetic damage that does not in any way affect the functionality of the keys, accessories, or equipment	a) loss or damage to keys or remotes.	
	<ul> <li>b) damage caused by incorrect fitting of accessories (snow chains, roof racks).</li> </ul>	
	c) damage to aerials.	
	<ul> <li>removal or damage to any item supplied with the vehicle (e.g. parcel shelf, tools, spare tyres, wheel trims, hazard triangles, first aid kits, fire extinguishers, child seats and electric vehicle charging cables)</li> </ul>
